Better Extreme Waiver

As with any sports activity, the safety of the participants is paramount. If you have attended a trampolining or skate centre before, you may have been required to sign a document stating that you have read, understood and agree with the company's terms and conditions. This is becoming standard practice when booking sports such as climbing, skating or trampolining.

On receipt of our booking, Better Extreme requested that we forward a copy of this document to all parents for their consideration - please see attached. Before our booking can be finalised, we must also notify the company of the names and dates of birth of all participants. Health and Safety

To ensure the trip is enjoyable and safe for all, we ask that parents discuss the rules attached with their child/children prior to the visit. On arrival at the park, the Better Extreme staff will go through these rules again and answer any questions. Staff will also show a video on how to use the equipment safely. Please note, that **the school will have sole use of the trampoline centre** during our visit and the children will not be mixing with the general public during their stay. School and centre staff will monitor activities at all times, operating a yellow (warning) and red card (time out) system if they observe unsafe jumps or children not abiding by the agreed rules.

Trampolining Socks

Following the safety introduction, all participants will be provided with a new pair of trampolining socks to wear. Please ensure that your child/children is aware of their shoe size as well as including this information on the reply slip below. It will mean that time spent on administrative tasks is kept to a minimum.
