## Provisional Kit List - Caythorpe Court 2020

## All essential activity and safety equipment is provided

We suggest that the children bring **old** clothes which you and they will not be sorry to throw away! Most of the activities require the children to wear a **long sleeved top and long trousers** – preferably not jeans. It can be quite chilly in the mornings at Caythorpe Court, so I would strongly recommend the children bring a fleece.

Tracksuit or flexible bottoms (three pairs)

Trousers/shorts – jeans for the evening

T shirts

3 Long sleeved tops

**Trainers** 

Casual shoes for spare time/indoors

Fleece

Socks - thick and thin

A light waterproof jacket (and trousers if available).

Several complete changes of underwear

Nightwear & Slippers

Handkerchiefs/Tissues

Several plastic bags (for wet/soiled linen)

Washing kit – flannel, **2** towels, soap, toothbrush, toothpaste, **roll-on** deodorants etc.

### Aerosol deodorants and all other aerosols are banned - Fire Regulations

Sunhat or cap – one which gives adequate protection to the whole head and in particular the back of the neck - **not** a sun visor.

Sun cream/After Sun

Lip balm

Pencil, pen, ruler etc.

Something to cuddle

Drinking water bottle

A small rucksack in which to carry cameras, sun cream and water bottle.

Reading book

Disco outfit!

Optional: disposable camera, travel alarm clock, pocket torch. The children may take pictures during the activities and evening entertainments but no in their rooms.

On arrival, PGL will confirm our evening entertainments. Occasionally, a disco is held on the last night, so it would be a good idea to pack something nice to wear.
